Labsii Sirna Qophii Wixinee Seeraa Mootummaa Naannoo Oromiyaa Murteessuuf Bahe, Lak. 222/2012

Naannoo keenya keessatti mirgoonni namoomaa akka kabajaman, imaammanni siyaas- diinagdee fi hawaasummaa mootummaan baasu hojjiirra akka oolan, sirni dimokiraasii akka dagaagu, misoomni akka dhufuu fi nagaafi tasgabbiin hawaasaa fulla'aa akka jiraatu gochuuf seeronni qulqullina qabaniifi raawwatamuu danda'an jiraachuun murteessaa waan ta'eef;

Seeronni wixineeffaman qulqullina, iftoomina, fudhatamummaa fi raawwatamummaa kan qabaniifi bifa wal-fakkaatuun akka hojjetaman gochuun rakkooleen hojii qophii wixinee seeraa keessatti mul'achaa turan bu'uura irraa akka furaman taasisuuf sirna dandeessisu diriirsuun uwwisa seeraa akka argatu taasisuun barbaachisaa ta'ee waan argameef;

Whereas, it is indispensable to have quality and enforceable laws to make the human rights be respected, the political, economic and social policies of the government be implemented, democratic system be advanced, development attained and sustainable peace and stability of the society be ensured in our region;

Whereas, it is found necessary to establish a system that avoids problems prevailing in legal drafting works fundamentally by making laws drafted to have a quality, transparency, acceptability, enforceability and prepared uniformly and provide legal framework;

1. **አጭር ርዕስ**
ይህ አዋጅ “የኦሮሚያ ክልላዊ መንግስት የህግ ረቂቅ ዝግጅት ሥርዓት አዋጅ ቁጥር 222/2012” ተብሎ ሊጠቀስ ይችላል፡፡
2. **ትርጓሜ**
የቃሉ አገባብ ሌላ ትርጉም የሚያሰጠው ካልሆነ በስተቀር በዚህ አዋጅ ውስጥ፡-
 - 1) “ሀተታ ዘምክንያት” ማለት በአዋጁ ይዘቶች ውስጥ የተደነገጉትን እና የአዋጁን አርቃቂ አስተሳሰቦች የሚገልፅ አጭር ጽሑፍ ነው፡፡
 - 2) “ጨፌ” ማለት በክልሉ ህገ-መንግስት አንቀጽ 46 (1) መሠረት የተቋቋመ የክልሉ ህግ-አውጪ እና ከፍተኛው የስልጣን ባለቤት የሆነ አካል ማለት ነው፡፡
 - 3) “ዓቃቤ ሕግ መሥሪያ ቤት” ማለት የኦሮሚያ ጠቅላይ ዓቃቤ ሕግ መሥሪያ ቤት ማለት ነው፡፡
 - 4) “የመንግስት አካል ወይም መሥሪያ ቤት” ማለት ህግ የማመንጨት ስልጣን ያለው የክልሉ የመንግስት አካል ወይም መሥሪያ ቤት ማለት ነው፡፡
 - 5) “ምክር ቤት” ማለት የኦሮሚያ ክልላዊ መንግስት መስተዳድር ምክር ቤት ማለት ነው፡፡

Whereas, it has become essential to clearly stipulate the power, duties and responsibilities of the government offices that initiate the law and participate in legal drafting activities by conducting policies and strategies implementation study and make such activity to be performed effectively;

Now, Therefore, in accordance with Article 49 (3) (a) of Oromia Regional State Revised Constitution, Proclamation No. 46/2001, it is hereby proclaimed as follows:

**Part One
General Provisions**

1. **Short Title**
This proclamation may be cited as “Oromia Regional State Legal Drafting Procedure Proclamation No. 222/2020.”
2. **Definitions**
Unless the context requires otherwise, in this Proclamation:
 - 1) “Drafting Explanatory Note” means a short note describing the rationales of the contents provided in the proclamation and the drafter of such proclamation.
 - 2) “Caffee” means the legislative and the highest organ of the Region, established in accordance with Article 46 Sub-Article 1 of the Constitution of the region.
 - 3) “Office of Attorney” means Office of Oromia Attorney General.
 - 4) “Government Body or Office” means government body or government office of the region having the power to initiate law.
 - 5) "Council" means Oromia Regional State Administrative Council.

- 6) "Naannoo" jechuun Naannoo Oromiyaa jechuudha.
- 7) "Nama" jechuun nama uumamaa yookiin qaama mirgi namummaa seeraan kennameef jechuudha.
- 8) "Wixinee Seeraa" jechuun wixinee Labsii, Dambii fi Qajeelfamaa qaama aangoon kennameefiin qophaa'u jechuudha.
- 9) "Qajeelfama Qophii Wixinee Seeraa" jechuun Qajeelfama qabiyyeen isaa akkaataa Labsii kana keessatti ibsameen ta'ee, seerri akka wixinaa'uuf barreeffamaan qaama wixinee qopheessuuf kennamu jechuudha.
- 10) "Qorannoo fi Qo'annoo" jechuun rakkoolee aango fi hojii mana hojjichaa karaa bu'aa qabeessa ta'een akka hin raawwatamne tasisan erga addaan baheen booda qorannoofi qo'annoo yaada seeraa burqisiisuuf yookiin seera haaraa baasuuf yookiin seera hojjiirra jiru fooyyeessuuf gaggeeffamu jechuudha.
- 11) "Yaada Seeraa Burqisiisuu" jechuun kaayyoo Labsii kanaatiif jecha rakkoo uumame seeraan hiikuuf yookiin qaawwaa seeraa foyya'uu qabu agarsiisuuf yaada qorannoon deegaramee dhiyaatuu dha.
- 12) "Waajjira" jechuun Waajjira Caffee Mootummaa Naannoo Oromiyaa jechuudha.

3. Ibsa Koornayaa

Labsii kana keessatti jechi koornayaa dhiiraatiin ibsame dubartiis ni dabalata.

4. Daangaa Raawwatiinsaa

Labsiin kun dhimmootaa fi qaamolee armaan gadii irratti raawwatiinsa ni qabaata:

- 1) Dhimmoota adeemsa yaada seeraa burqisiisuu irraa hanga seera wixineessuutti jiran;
- 2) Manneen Hojii yookiin Qaamolee Mootummaa adeemsa yaadni seeraa burqisiisuu seeraan kennameef;
- 3) Manneen Hojii aangoon seera wixineessuu Labsii kanaan kennameef.

- 6) "ክልል" ማለት የኦሮሚያ ክልል ማለት ነው።
- 7) "ሰው" ማለት የተፈጥሮ ሰው ወይም በህግ የሰውነት መብት የተሰጠው አካል ማለት ነው።
- 8) "የህግ ረቂቅ" ማለት ሥልጣን በተሰጠው አካል የሚዘጋጅ የአዋጅ፣ የደንብ እና መመሪያ ረቂቅ ማለት ነው።
- 9) "የህግ ረቂቅ ዝግጅት መመሪያ" ማለት ይዘቱ በዚህ አዋጅ ውስጥ በተገለጸው መሰረት ሆኖ፣ ህግ እንዲረቀቅ የህግ ረቂቅ ለሚያዘጋጅ አካል በጽሁፍ የሚሰጥ መመሪያ ማለት ነው።
- 10) "ጥናትና ምርምር" ማለት የመሥሪያ ቤቱን ሥልጣንና ተግባር ውጤታማ በሆነ መንገድ እንዳይፈጸም ያደረጉት ችግሮች ከተለዩ በኋላ የህግ ሀሳብ ለማመንጨት ወይም አዲስ ህግ ለማውጣት ወይም ሥራ ላይ ያለ ህግን ለማሻሻል የሚካሄድ ጥናትና ምርምር ማለት ነው።
- 11) "የህግ ሀሳብ ማመንጨት" ማለት ለዚህ አዋጅ አላማ ሲባል የተፈጠረን ችግር በህግ ለመፍታት ወይም መሻሻል ያለበትን የህግ ክፍተት ለማመላከት በጥናት ተደግፎ የሚቀርብ ሀሳብ ነው።
- 12) "ጽሁፈት ቤት" ማለት በኦሮሚያ ክልላዊ መንግሥት የጨፌ ጽሁፈት ቤት ማለት ነው።

3. የጾታ አገላለፅ

በዚህ አዋጅ ውስጥ በወንድ ጾታ የተገለፀ ቃል ሴትንም ይጨምራል።

4. የተፈጻሚነት ወሰን

ይህ አዋጅ በሚከተሉት ጉዳዮችና አካላት ላይ ተፈጻሚነት ይኖረዋል፡-

- 1) የህግ ሀሳብ ከማመንጨት ሒደት እስከ ህግ ማርቀቅ ድረስ ባሉ ጉዳዮች፤
- 2) የህግ ሀሳብ የማመንጨት ሂደት በህግ በተሰጣቸው መሥሪያ ቤቶች ወይም የመንግሥት አካላት፤
- 3) በዚህ አዋጅ ህግ የማርቀቅ ስልጣን በተሰጣቸው መሥሪያ ቤቶች።

- 6) "Region" means Oromia Region.
- 7) "Person" means natural or juridical person.
- 8) "Legal Draft" means draft of proclamation, regulation and directives prepared by a body mandated with such power.
- 9) "Legal Drafting Instruction" means an instruction that its content is as stated in this proclamation and provided in writing to the legal drafting body for the law to be drafted.
- 10) "Research and Studies" means a research and study conducted to initiate law, to enact new law, or to amend the existing law after identifying the problems that hinder the effective implementation of the power and duties of the office.
- 11) "Initiation of Law" means for the purpose of this proclamation, an idea provided and supported by research to resolve problem occurred through law or to indicate legal gap to be amended.
- 12) "Office" means the Secretariat of Caffee Regional State of Oromia.

3. Gender Reference

In this proclamation, any term expressed in masculine gender includes the feminine gender.

4. Scope of Application

This proclamation shall be applicable to the following issues and organs:

- 1) Issues from initiating the law to drafting the law;
- 2) Offices or government organs legally authorized to initiate laws;
- 3) Offices empowered to draft the law by this proclamation.

Kutaa Lama

Adeemsa Yaada Seera Burqisiisuu, Wixineessuu fi Qabiyyee Qajeelfama Qophii Wixinee Seeraa

5. **Adeemsa Yaada Seera Burqisiisuu** Manni Hojii yookiin Qaamni Mootummaa aangoon yaada seeraa burqisiisuu kennameef kamiyyuu:

- 1) Qorannoo yookiin qaawwa xiinxala raawwii hojii irratti gaggeeffameen rakkoon uumame haguug-gii seeraatiin furmaata kan argatu ta'uu isaa mirkaneessuu;
- 2) Yaada barbaachisummaa seeraa burqee fi qajeelfama qophii wixinee seeraa qopheessuun qaama seera akka wixineessuuf aangoon kennameeffitti dhiyeessuu qaba.

6. **Adeemsa Seera Wixineessuu** Seerri yammuu wixinaa'uu adeemsaalee armaan gadii hordofuun kan raawwatamu ta'a:

- 1) Wixineessaan Labsii kana Keewwata 5 jalatti tumaalee adeemsa yaada seera burqisiisuu ilaalchisee tumaman guutamanii dhiyaachuu isaanii mirkaneeffachuu qaba.
- 2) Kan Keewwata kana Keewwata Xiqqaa 1 jalatti tumame akkuma eegametti ta'ee, wixineessaan haalawwaan armaan gadii guutamanii dhiyaachuu isaanii mirkaneeffachuu qaba:
- (a) Qorannoo dhiyaate xiinxaluun ulaagaalee guutee dhiyaachuu isaa mirkaneeffachuu;
- (b) Qabiyeen qajeelfama qophii wixinee seeraa guutummaa qabaachuu isaa mirkaneessuu.

7. **Qabiyyee Qajeelfama Qophii Wixinee Seeraa**

Qajeelfamni qophii wixinee seeraa kan qophaa'uu barreeffamaan ta'ee, qabxiilee armaan gadii hammachuu qaba:

- 1) Kaayyoo bu'uuraa seera wixinaa'uu qabuu ifaa fi haala guutuu ta'een ibsuu;

5. **የህግ ሀሳብ የማመንጨት ሂደት** የህግ ሀሳብ የማመንጨት ሥልጣን የተሰጠው ማንኛውም መሥሪያ ቤት ወይም የመንግሥት አካል፡-

- 1) በጥናት ወይም በህግ አፈፃፀም ክፍተቶች ላይ በተደረገ ግምገማ የተፈጠረ ችግር በህግ ማዕቀፍ መፍትሄ የሚያገኝ መሆኑን ማረጋገጥ፤
- 2) የመነጨው የህግ አስፈላጊነት ሃሳብ እና የህግ ረቂቅ አዘገጃጀት መመሪያ በማዘጋጀት ህግ ለማርቀቅ ስልጣን ለተሰጠው አካል ማቅረብ አለበት፡፡

6. **ሕግ የማርቀቅ ሂደት** ህግ ሲረቀቅ የሚከተሉትን ሂደቶች በመከተል የሚከናወን ይሆናል፡-

- 1) አርቃቂው በዚህ አዋጅ አንቀጽ 5 ሥር የህግ ሀሳብ የማመንጨት ሂደትን አስመልክቶ የተደነገጉት ድንጋጌዎች ተሟልተው መቅረባቸውን ማረጋገጥ አለበት፤
- 2) በዚህ አንቀጽ ንዑስ አንቀጽ 1 ሥር የተደነገገው እንደተጠበቀ ሆኖ፤ አርቃቂው የሚከተሉት ሁኔታዎች ተሟልተው መቅረባቸውን ማረጋገጥ አለበት፡-
- (ሀ) የቀረበውን ጥናት በመገምገም መስፈርቶቹን አሟልቶ የቀረበ መሆኑን ማረጋገጥ፤
- (ለ) የህግ ረቂቅ አዘገጃጀት መመሪያ ይዘትን በተሟላ ሁኔታ የያዘ መሆኑን ማረጋገጥ፡፡

7. **የህግ ረቂቅ ዝግጅት መመሪያ ይዘት** የህግ ረቂቅ ዝግጅት መመሪያ የሚዘጋጀው በፅሁፍ ሆኖ፤ የሚከተሉትን ነጥቦች መያዝ አለበት፡-

- 1) መረቀቅ ያለበትን ህግ መሰረታዊ ዓላማ በግልጽና በተሟላ ሁኔታ መግለፅ፤

Part Two

Law Initiation Process, Drafting and Contents of Drafting Instruction

5. **Law Initiation Process** Any office or government organ empowered to initiate the law shall:

- 1) Ensure whether the problem identified by research or the gap indicated through analysis conducted on work performance is resolved through legal framework;
- 2) Prepare opinion about the significance of the initiated law and drafting instruction and submit same to the body empowered to draft law.

6. **Legal Drafting Process** Drafting the law shall be performed pursuing the following processes:

- 1) The drafter shall ensure that the law initiation process provisions stipulated under article 5 of this proclamation is fulfilled;
- 2) Without prejudice to the provision under sub article 1 of this article, the drafter shall also ensure the fulfillment of the following conditions:
 - (a) Analyze and ensure that the research submitted fulfills the criteria;
 - (b) Ascertain that the content of the drafting instruction is full.

7. **Contents of Drafting Instruction** The drafting instruction shall be prepared in writing and contains the following points:

- 1) State the basic purpose of the law to be drafted precisely and adequately;

- 2) Seerichi akkamitti hojiirra akka ooluu fi qaama hojiirra oolchu agarsiisuu;
- 3) Dhiibbaa seerichi aangoo fi hojii manneen hojii biroo irratti qabu ibsuu;
- 4) Seerri wixinaa'uu qabu dhiibbaa inni hojii mana hojii mootummaa biraa irratti geessisu yoo jiraate mana hojichaa mariisuu isaa agarsiisuu;
- 5) Odeeffannoowwan duuba seerichaa kanneen akka rakoo qabatamaa seerichi furuuf bahuu, kallattii furmaataa fi seerichi yammuu bahe faayidaa hawaasaaf qabu ibsuu;
- 6) Seerotni duraan turan akka fooyya'aniif yookiin seerri haaraan akka bahuuf yookiin qaawwa seerota hojiirra jiranii guutuuf ta'uu isaa agarsiisuu;
- 7) Seericha baasuun imaammata mootummaa hojiirra ooluu danda'u ibsuu;
- 8) Akkaataa barbaachisummaa isaatti sababa wixinichi dursa wixineeffamuu qabuuf ibsuu;
- 9) Wixineen seera haaraa qophaa'uuf jedhu yookiin kan duraan ture fooyyessuuf jedhu kun seerota hojiirra jiran haqsiisuu yookiin fooyyessuu kan danda'u yoo ta'e dhiibbaa fiduu danda'u agarsiisuu;
- 10) Labsiin duraan jiru kan fooyya'u yookiin haqamu yoo ta'e, Dambii fi Qajeelfamoonni bu'uura Labsichaatiin bahanii fi qaamoleen bu'uura Labsii yookiin Dambii fooyya'u yookiin haqamuuf jedhuun hundaa'an maal ta'uu akka qaban ibsuu;
- 11) Aangoo fi hojii mana hojii wixinichi qophaa'uufii ibsuu;
- 12) Wixineen seerichaa ragga'u yeroon hojiirra itti oolu haala baratameen alatti gara fuulduraatti yoo ta'e ibsamuu;

- 2) ህጉ እንዴት ስራ ላይ እንደሚውልና ስራ ላይ የሚያውለውን አካል ማሳየት፤
- 3) ህጉ በሌሎች መሥሪያ ቤቶች ስልጣንና ተግባር ላይ ያለውን ተጽዕኖ መግለፅ፤
- 4) የሚረቀው ህግ በሌላ የመንግሥት መሥሪያ ቤት ተግባር ላይ የሚያስከትለው ተጽዕኖ ካለ መሥሪያ ቤቱን ያወያየ መሆኑን ማሳየት፤
- 5) የህጉን የኋላ መረጃዎች የሚወጣው ህግ ሊፈታው የሚሄደው ተጨባጭ ችግር፣ የመፍትሄ አቅጣጫ እና ህጉ ሲወጣ ለማህበረሰቡ ያለውን ጥቅም መግለጽ፤
- 6) በስራ ላይ ያሉ ህጎች እንዲሻሻሉ ወይም አዲስ ህግ እንዲወጣ ወይም በስራ ላይ ያሉ ህጎችን ክፍተት ለመሙላት መሆኑን ማሳየት፤
- 7) ህጉን በማውጣት ሥራ ላይ ሊውል ስለሚችለው የመንግሥት ፖሊሲ መግለፅ፤
- 8) እንደ አስፈላጊነቱ ረቂቁ በቅድሚያ መረቀቅ ስለሚኖርበት ምክንያት መግለፅ፤

- 4) If the law to be drafted may have an impact on another government office, indicate the discussion held with such office;
- 5) Provide background information of the law to be drafted like the actual problem that such law is enacted to solve, the way forward and the benefit it has for the society if enacted;
- 6) Indicate whether it is for amendment of the existing laws or for enactment of new law or to fill gaps of the laws in force;
- 7) Indicate government policy to be implemented by enacting the law;
- 8) State the reason for giving priority in preparation of such draft as may deem necessary;
- 9) Indicate the impact of the law to be drafted or amended on the existing law if it may result in repealing or amending of the laws in force;
- 10) If the existing proclamation is amended or repealed, recommend fate of the regulation and directives enacted on the basis of such proclamation and the organs established in accordance with the proclamation or regulation to be amended or repealed;
- 11) State the power and duties of the office for which the draft is prepared;
- 12) If the draft law to be approved is unconventionally intended to come in to force in the future, such fact shall be stated;

- 13) Seera haaraa bahuun yookiin fooyya'uun dirqamni yookiin dhimmi gara qaama seera haaraa kanaan hundeeffamutti darbu yookiin akkuma duraan turetti akka itti fufu barbaadamu yoo jiraate ifa gochuu; fi

8. Contents of Research and Studies of Legal Drafting

The contents of legal drafting research and study shall be the following:

- 1) Legal drafting research and study conducted for implementation of policy shall state:
 - (a) Explain the situation and scope of the policy needed to be implemented;
 - (b) Other policy directly or indirectly related with the policy needed to be implemented through enacting law;
 - (c) Explain the possible options for implementing the policy;
 - (d) Whether enacting law is a mandatory to implement the policy;
 - (e) Explain whether the law to be enacted for implementing the policy is proclamation, regulation, or directive.
- 2) Legal drafting research and study conducted for solving existing problem shall:
 - (a) Indicate clearly the problems terms of their nature, scope, being redundant and in terms of their adverse effects;
 - (b) Indicate that the problem cannot be solved except by enacting law;
 - (c) Indicate that the enactment of the law is efficient, cost effective and it provides additional benefit;

- (d) Rakkoon adda bahe sun seera hojii irra jiruun kan hin haguugamne yookiin kan hin furamne ta'uu sirriitti adda baasuufi seera baasuun dirqama ta'uu isaa sababa gahaan ibsuu;

9. Contents of Drafting Explanatory Note

The content of drafting explanatory note shall be the following:

- 1) Introduction;
- 2) Brief statement of the problem, the solution that the drafted law has brought about and the mechanism for solving such problem;
- 3) Explain the story of the problem in general terms;
- 4) Detail explanation of the main provisions of the draft law.

Part Three

Basic Principles, Process, Stages and Organization of Legal Drafting

10. Basic Principles of Legal Drafting

- 1) **Inclusiveness**
(a) The draft law to be prepared shall be applicable on all persons or matters that it is enacted to govern;
- (b) The draft law shall be prepared in a manner that it shall be uniformly implemented in all places and at the same time.
- 2) **Predictability**
The draft law to be prepared shall take into account the actual situation prevailing in the society at that time, the change that is likely to occur in the future and the advantages and disadvantages expected as a result of implementation of the law.

- 3) Iftoomina Qabaachuu
- (a) Wixineen seeraa yammuu qophaa'u qaamoleen dhimmi ilaallatu hundi odeeffannoo gahaa akka qabaatanii fi yaada isaanii wixinicha irratti akka kennan taasifamuu qaba.

- 3) Transparency
- (a) while preparing the draft law, all the concerned bodies shall be given adequate information and shall be enabled to provide their opinion on the draft law;
- (b) The legal draft shall be prepared in a way that the legislative, executive, the judiciary and the bodies that directly or indirectly benefit from such law can easily understand it.
- 4) Proportionality
The benefits and negative impact of the draft law to be prepared has on the society shall be proportional.
- 5) Develop the Culture, History and Values of the Region
The law drafted at the region shall include the culture, history and values that the people of the region inherited from the Gada system, build up peaceful coexistence and love, develop democratic system and enable to build prosperous region.

- 11. Legal Drafting Process**
The law to be drafted shall be prepared by pursuing the principles specified below:
- 1) The draft law shall be prepared in a clear and easily understandable manner;
 - 2) Articles of the draft law shall be arranged in a way supporting each other;
 - 3) Provisions of the draft shall as much as possible be short and easily understandable;
 - 4) The term used to express one issue or concept shall be uniform throughout the draft;
 - 5) If the legal draft is prepared in three languages, the structure of the draft and the definition of provisions of all languages shall be compatible;

Wixineen seeraa yammuu qophaa'u kallattii Heera Mootummaa Federaalaa fi Naannichaa, seerota hojiirra jiran, barbaachisummaa seericha bahuu, hojiirra oolmaa seerichaa, dhiibbaa seerichi diinagdee, haawaasummaa fi haala naannoo irratti qabu waliin xiinxalamuu qaba. Tarreeffamni isaa Maanuwaalii bahuun kan murtaa'u ta'a.

3) Seera Bocuu

Seerri wixinaa'u akkaataa dhimmichaatiin akka barbaachisummaa isaatti walduraa duubaan Boqonnaan, Kutaan, Kutaa Xiqqaan, Keewwataa fi Keewwata Xiqqaadhaan kan bocamu ta'a.

4) Qindeessuu fi Gabbisuu

Seerri wixinaa'u wixineessaan erga qindaa'ee booda qaamolee dhimmichi ilaallatu yookiin haawaasa mariisiisuun gabbachuu qaba.

5) Qorachuu fi Madaaluu

Wixineen seeraa erga qophaa'e booda kallattii kaayyoo fi imaammata seerri bahu galmaan gahuu danda'uun wixineeffamuun isaa sakatta'amu fi madaalamuu qaba.

2) ምርመራ ማካሄድ

የህግ ረቂቅ ሲዘጋጅ ከፌዴራልና ከክልሉ ህገ-መንግስት፣ ስራ ላይ ካሉ ህጎች፣ ከሚወጣው ህግ አስፈላጊነት፣ ከህጉ ስራ ላይ መዋል፣ ህጉ በኢኮኖሚ፣ በማህበራዊና በአካባቢ ሁኔታ ላይ ያለው ተጽዕኖ አንጻር መመርመር አለበት። አፈፃፀሙ በሚወጣው ማኑዋል የሚወሰን ይሆናል።

3) ህግ መቅረጽ

የሚረቀቀው ህግ እንደ ጉዳዩ ሁኔታ እንደ አስፈላጊነቱ በምዕራፍ፣ በክፍል፣ በንዑስ ክፍል፣ በአንቀጽና በንዑስ አንቀጽ እንደ ቅደም ተከተላቸው የሚቀረጽ ይሆናል።

4) ማቀናጀትና ማዳበር

የሚረቀቀው ህግ በአርቃቂው ከተቀናጀ በኋላ የሚመለከተውን አካል ወይም ሀብረተሰቡን በማወያየት መዳበር አለበት።

5) መፈተሽና መመዘን

የህግ ረቂቅ ከተዘጋጀ በኋላ የሚወጣው ህግ የወጣበትን ዓላማና ፖሊሲ ማሳካት ከመቻሉ አንጻር መፈተሽና መመዘን አለበት።

6) The draft law shall mention the legislative body source of power.

12. Stages of Legal Drafting

Legal drafting shall have the following stages:

1) Understanding the Interest of Law Initiating Organ

Legal draft shall be prepared by understanding the interest of the law initiating office from the research conducted and the drafting instruction given.

2) Conducting Analysis

While preparing the draft law, it shall be analyzed in relation with the Federal and Regional Government Constitutions, the laws in force, the importance of the law to be enacted, enforcement of the law, the impacts of such law on the economic, social and environmental condition; Its particulars shall be determined by the manual to be issued.

3) Designing The Law

The legal draft shall be designed in chapters, parts, sub parts, articles and sub articles respectively depending on the issue as may be necessary.

4) Composing and Developing

After the drafter composes the draft law, it shall be developed through discussion with the concerned body or the society.

5) Investigating and Evaluating

After the draft law is prepared, it shall be examined and evaluated to check that it is drafted as per the objective and policy that it can attain.

13. Gurmaa'ina Wixinee Seeraa

13. Organization of the Legal Draft

Legal draft shall have the following organization:

- 1) In general: Long title, introduction, enabling clause, short title, definition, body of the law and miscellaneous provisions;
- 2) Without prejudice to the provision under sub-article 1 of this article in general, legal drafting shall be organized as follows pursuing its flow of ideas:
 - (a) Articles proclaiming the law shall be identified from the administrative provisions and shall come at first;
 - (b) Simple provisions shall precede complex provisions; simple penalty provisions shall precede severe penalty imposing provisions;
 - (c) Basic provisions shall be identified from subsequent provisions and come at first;
 - (d) Special provisions, temporary provisions, provisions repealing existing laws shall be provided differently under the title termed miscellaneous provisions;
 - (e) Provisions entitling rights and imposing duties, entitling special power or rights shall be structured preceding the provisions concerning implementations of administrative and procedural matters;
 - (f) Provisions concerning about having similar issues shall be provided under one part or together; Its particulars shall be determined by the manual to be prepared.

Part Four

Power, Duties and Responsibilities of Government Offices and Bodies

14. Common Power and Duties

Without prejudice to the power and duties given to them by other laws, government offices and bodies shall have the following common power and duties in connection with legal drafting:

- 1) Initiate ideas of law that help for the implementation of the power and duties legally given to them;
- 2) Undertake research and/or studies regarding the law ideas they have initiated;
- 3) Prepare legal drafting instruction in accordance with article 6 of this proclamation and submit same to the drafting body.

15. Responsibilities of the Government Offices or Bodies

- 1) Any government office not directly accountable to the Caffee requiring the legal draft to be prepared for it shall have a duty to fulfill and submit the following:
 - (a) To send its legal drafting plan of one fiscal year to the Office of the Attorney at the commencement of such budget year;
 - (b) That the law is permitted to be drafted by the body empowered;
 - (c) To submit the research conducted for drafting the law and the legal drafting instruction;
 - (d) Establishing work relationships between the law drafting office and the office for which the law is drafted and make follow up from time to time and to participate on the discussion and provide necessary explanation whenever required;
 - (e) Taking the correction given from office of the Attorney and correct accordingly and return within the time prescribed.

- 3) Any office or body which is directly accountable to the Caffee requiring the legal draft to be prepared for it shall have a duty to fulfill and submit the following:
 - (a) Sending its legal drafting plan of one fiscal year to the Secretariat of Caffee at the commencement of such fiscal year;
 - (b) That the law is permitted to be drafted by the body empowered;
 - (c) To submit the research conducted for drafting the law and the legal drafting instruction;
 - (d) Establishing work relationships between the law drafting office and the office for which the law is drafted and make follow up from time to time and to participate on the discussion and provide necessary explanation whenever required;
 - (e) Take the correction given from the office, correct accordingly, and return within the time prescribed.
- 4) Notwithstanding to the provision under sub-article 1(a) of this article, an office may submit the need for a draft of law which is not included in the plan for the office with adequate grounds.

16. Power and Duties and Responsibilities of the Office

- 1) Power and Duties of the Office: Without prejudice to the power and duties vested in it by other laws, the office shall have the following power and duties regarding legal drafting:

- (a) Receive research and studies conducted on the issue submitted by the government bodies or offices directly accountable for the Caffee requiring law to be drafted for them; analyze the research deeply and ensure that it fulfills the required criteria;
- (b) Receive and analyze the legal drafting instruction submitted from the government bodies or offices specified under sub-Article 1 of this article; prepare the legal draft;
- (c) If the government office or body fails to comply with the obligations provided under Article 15 sub-article 3 of this proclamation and if the legal drafting body fail to discharge the obligation expected from it regarding the draft within fifteen (15) working days as of the date it is required to fulfill such obligation, it shall return the submitted draft or the legal drafting proposal to the concerned government office or body;
- (d) Without prejudice to the provisions under sub article 1(c) of this article, the legal drafting proposal that has been returned to the government office may be submitted as newly.
 - 2) Responsibility of the Office
The Office shall have the following responsibilities:
 - 1) Conduct research and studies regarding ideas of law initiated by bodies of the Caffee for preparing legal draft; prepare the legal draft based on the research;
 - 2) Receive the legal ideas from government offices or bodies directly accountable to the Caffee, ascertain that they have met the necessary criteria; make the necessary correction; prepare legal draft;

- (c) Wixinee Afaan Oromoo, Amariiffaa fi Ingiliffaan qopheesse hii-ka afaan sadaniin walsimate ni dhiyeessa;
- (d) Wixinee qophaa'e marii hawaas-aatiin akka gabbatu ni taasisa;

- 3) በምክር ቤቱ የፀደቁ ደንቦችን ለዓቃቤ ህግ መሥሪያ ቤት ይልካል፤
- 4) ለህግ ረቂቅ ዝግጅት ሥራ ውጤታማነት ከዓቃቤ ህግ መሥሪያ ቤት እና ጉዳዩ ከሚመለከተው መሥሪያ ቤት ጋር ይሰራል።

18. የዓቃቤ ህግ መሥሪያ ቤት ስልጣን፣ ተግባር እና ሃላፊነት

- 1) የዓቃቤ ህግ መሥሪያ ቤት ስልጣንና ተግባር
በሌሎች ህጎች የተሰጠው ስልጣንና ተግባር እንደተጠበቀ ሆኖ፣ የህግ ረቂቅ ዝግጅትን በተመለከተ የዓቃቤ ህግ መሥሪያ ቤት የሚከተለው ስልጣንና ተግባር ይኖረዋል፡-
- (ሀ) ህግ እንዲረቀቅለት የሚፈልግ መሥሪያ ቤት አስፈላጊ መስፈርቶችን ማሟላቱን ያረጋግጣል፤ ይተነትናል፤

- 3) Prepare a draft of law in Afan Oromo, Amharic and English and present the translation consistent in the three languages;
- 4) Make the prepared draft to be developed with public hearing;
- 5) Submit the prepared or corrected draft to the Coordinating Committee.

17. Responsibility of the President Office

Without prejudice to the responsibilities vested in it by other laws, Office of the President of the Region shall:

- 1) Facilitate conditions for government offices that are not directly accountable to the Caffee, requiring law to be enacted for them, to submit their legal drafting plan at the commencement of the fiscal year;
- 2) Send the drafts of Proclamations examined by the Council and approved Regulations to the Secretariat of Caffee;
- 3) Send Regulations approved by the Council to office of the Attorney;
- 4) Work with the office of the Attorney and the concerned government office for the effectiveness of legal drafting.

18. Power, Duties and Responsibilities of Office of the Attorney

- 1) Power and Duties of Office of the Attorney
Without prejudice to the power and duties vested in it by other laws, office of the Attorney shall have the following power and duties regarding Legal Drafting:
- (a) Ascertain whether the government office requiring law to be drafted for it has met the necessary criteria; analyze same;

- (b) Bu'uura Labsii kana Keewwata 7tiin Qajeelfama Qophii Wixinee Seerichaa Mana Hojii irraa dhiyaatu simatee ni xiinxala; Wixinee Seeraa ni qopheessa;
 - (c) Manni Hojii bu'uura Labsii kana Keewwata 15 tiin dirqamoota tumaman guutee yoo hin dhiyeessin qaamni wixinee seerichaa qopheessuu wixinicha guyyaa dirqama irraa eegamu akka guutu gaafatamee irraa eegalee guyyaa hojii kudha shan keessatti yoo bahachuu baate wixinichi yookiin yaada seera wixineessuu dhiyaatee ture mana hojii dhimmi ilaaluuf ni deebisa.
 - (d) Kan Keewwata kana Keewwata Xiqqaa 1(c) jalatti tumame akkuma eegametti ta'ee, yaadni seera wixineessuu mana hojiitiif deebi'ee ture bifa haaraan dhiyaachuu ni danda'a.
- 2) Ittigaafatamummaa Mana Hojii Abbaa Alangaa
Manni Hojii Abbaa Alangichaa-itti gaafatamummaa armaan gadii ni qabaata:
- (a) Dhimmoota aangoo Mana Hojii Abbaa Alangichaa ta'an irratti seera baasuun yoo barbaachise qajeelfama wixinee seeraa qopheessuun kutaa dhimmi ilaaluuf ni kenna;
 - (b) Manni Hojii Abbaa Alangaa Wixinee seeraa akka qopheessu mootummaan yoo gaafatame qajeelfamni wixinee seeraa akka kennamu haala ni mijeessa;
 - (c) Wixineen seeraa akka qophaa'u mootummaadhaan yammuu gaafatamu qorannoo fi qo'annoo gaggeessuun yookiin qorannoo gaggeeffame bu'uureffachuun wixinee seeraa ni qopheessa;
 - (d) Wixinee Afaan Oromoo, Amaariffaa fi Ingiliffaan qophaa'uun hiika afaan sadaniin walsimate dhiyeessuu;

- 2) የዓቃቤ ህግ መሥሪያ ቤት ሐላፊነት የዓቃቤ ህግ መሥሪያ ቤት የሚከተለው ሐላፊነት ይኖረዋል፡-
- (ሀ) የዓቃቤ ሕግ መሥሪያ ቤቱ ሥልጣን በሆኑ ጉዳዮች ላይ ህግ ማውጣት ካስፈለገ፣ የህግ ረቂቅ መመሪያ በማዘጋጀት ለሚመለከተው የስራ ክፍል ያቀርባል፤
 - (ለ) የዓቃቤ ህግ መሥሪያ ቤት የህግ ረቂቅ እንዲያዘጋጅ በመንግሥት ከተጠየቀ፣ የህግ ረቂቅ መመሪያ እንዲሰጥ ሁኔታዎችን ያመቻቻል፤
 - (ሐ) የህግ ረቂቅ እንዲዘጋጅ በመንግሥት ሲጠየቅ፣ ጥናትና ምርምር በማካሄድ ወይም የተካሄደውን ምርምር መሰረት በማድረግ የህግ ረቂቅ ያዘጋጃል፤
 - (መ) በአፋን ኦሮሞ፣ በአማርኛና በእንግሊዝኛ ረቂቅ በማዘጋጀት በሶስቱ ቋንቋዎች የሚጣጣም ትርጉም ያቀርባል፤

- (b) Receive and analyze the Legal Drafting Instruction submitted by the government office pursuant to Article 7 of this Proclamation; prepare the legal draft;
 - (c) If the government office fails to comply with the obligations provided under Article 15 of this proclamation and if the legal drafting body fail to discharge the obligation expected from it regarding the draft within fifteen working days as of the date it is required to fulfill such obligation, it shall return the submitted draft or the legal drafting proposal to the concerned government office;
 - (d) Without prejudice to the provisions under sub article 1(c) of this article, the legal drafting proposal that has been returned to the government office may be submitted newly.
- 2) Responsibilities of Office of the Attorney
Office of the Attorney shall have the following responsibilities:
- (a) Prepare legal drafting instruction and submit it to the concerned department where it is necessary to enact laws on issues falling under the mandate of office of the Attorney;
 - (b) Facilitate conditions for the legal drafting instruction to be presented if the office of the Attorney is required by the government to prepare legal draft;
 - (c) Prepare the legal draft by conducting research and studies or based on the research conducted when it is required by the government to prepare legal draft;
 - (d) Present the draft prepared in Afan Oromo, Amharic and English with consistent translation of the three languages;

- (e) Wixinee qophaa'e yookiin sirraa'e mariin akka gabbatu qaama yaada seeraa wixinichaa dhiyeessee fi akka barbaachisummaa isaatti qaama dhimmi ilaalu waliin ni hojjeta; ni sirreessa;
- (f) Wixinee qophaa'ee yookiin sirraa'e ibsa wixinichaa waliin Waajjira Pirezidaantiif ni erga;
- (g) Seerota ragga'an galmeessee ni qabata.

Seera burqisiisuu fi wixinessuu ilaalchisee seerota birootiin kan tumaman akkaataa tumaalee Labsii kanaatiin wal-simatani hojiira kan oolan ta'a.
- 20. **Dirqama Deeggarsa Kennuu**
Manni hojii kamiyyuu Labsii kanaa fi maanuwaalii bu'uurra Labsii kanaatiin bahu raawwachiisuuf deeggarsa kennuuf dirqama ni qabaata.
- 21. **Seerota Raawwatiinsa Hin Qabaanne**

- 22. **Aangoo Maanuwaalii Baasuu**
Labsii kana raawwachiisuuf Koreen Mari'achiiftuu Dhimmoota Caffee fi Manni Hojii Abbaa Alangaa Waliigala Oromiyaa Maanuwaalii baasuu ni danda'u.
- 23. **Yeroo Labsiin Kun Hojiirra Itti Oolu**
Labsiin kun guyyaa Magalata Oromiyaa irratti maxxanfame irraa eegalee hojiirra kan oolu ta'a.

- (e) Work with the body that present idea legal draft and as deemed necessary with other concerned body for the draft prepared or corrected to be developed in dialogue; corrects it;
- (f) Present the prepared or corrected draft to the office of the president with the descriptions of such draft;
- (g) Register and maintain the approved laws.

Part Five

Miscellaneous Provisions

- 19. **Power To Initiate Law and Drafting Law**
Provisions by other laws regarding initiating and drafting the law shall be implemented in the way consistent with the provisions of this proclamation.
- 20. **Duty To Cooperate**
Any government office shall have a duty to cooperate for the implementation of this proclamation and manual issued pursuant to this proclamation.
- 21. **Inapplicable Laws**
Any law or customary work practices in contradiction with the provisions of this proclamation shall not be acceptable.
- 22. **Power To Issue Manual**
The Caffee Affairs Advisory Committee and Office of Oromia Attorney General may issue manual for the implementation of this proclamation.
- 23. **Effective Date**
This proclamation shall come in to force as of the date of its publication on Megeleta Oromia.
