Labsii Itti waamama Tumsa Indoowumantii Misooma Oromiyaatiif Murteessuuf Bahe, Lak. 225/2012

Tumsa Indoowumantiin dhaabbata qabeenya naannoo Oromiyaatiin kan hundaàe waan taàef faayidaa ummata naannichaatiif akka oolu gochuun barbaachisaa taàe waan argameef;

Tumsa Indoowumantiin akkaataa ummanni naannichaa hojii misooma hawaasummaa fi diinagdee indoowumantichi gaggeessu irraa fayyadamaa ta'uu fi gara mootummaatiin hordofamuu fi to'atamu sirna diriirsuun barbaachisaa waan taàef;

Proclamation to Determine the Accountability of Tumsa Endowment For The Development Of Oromia, No. 225/2020

Whereas, it is found necessary to make Tumsa Endowment for the Development of Oromia to be used for the benefit of the people of the region as it is an organization established by the resources of Oromia region;

Whereas, it is necessary to establish a system whereby the people of the region shall benefit from the social and economical development activities undertaken by Tumsa Endowment and the Endowment can be followed and controlled by the government;

Kaayyoo fi ergama indoowumantichi hundeeffameef haala bu'aa qabeessa ta'een fiixaan akka bahuu fi hojii indoowumantichaa dhiyeenyatti karaa Abbaa Taayitaa To'annoo Dhaabbilee Misooma Mootummaa Naannoo Oromiyaatiin akka hordofamuu fi to'atamu taasisuun barbaachisaa waan ta'eef;

Akkaataa Heera Mootummaa Naannoo Oromiyaa Fooyya'ee Bahe, Labsii Lak. 46/1994 Keewwata 49 Keewwata Xiqqaa 3(a) tiin kan kanatti aanu lab-sameera.

1. **Mata Duree Gabaabaa**
Labsiin kun “**Labsii Itti waamama Tumsa Indoowumantii, Lak. 225/2012**” jedhamee waamamuu ni danda'a.
2. **Hiika**
Akkaataan jechichaa hiika biroo kan kennisiisuuf yoo ta'e malee, Labsii kana keessatti:
 - 1) “Abbaa Taayitaa” jechuun Abbaa Taayitaa To'annoo Dhaabbilee Misooma Mootummaa Naannoo Oromiyaa jechuudha.
 - 2) “Boordii” jechuun boordii hojii gaggeessaa Tumsa Indoowumantii Misooma Oromiyaaf akkaataa Dambii hundeeffama Indoowumantichaatiin hunda'ee jechuudha.
 - 3) “Indoowumantii” jechuun Tumsa Indoowumantii Misooma Oromiyaatiif akkaataa Labsii Dhaabbilee Siivilii Hawaasaatiin hundeeffame jechuudha.
 - 4) “Mootummaa” jechuun mootummaa naannoo Oromiyaa jechuudha.
3. **Daangaa Raawwatiinsaa**
Labsiin kun hojiiwwan misooma hawaasummaa fi dinagdee Tumsa Indoowumantiin ofii isaatiin gaggeessuu fi qooda yookiin sheerii indoowumantichi dhaabbilee biroo keessaa qabu hunda irratti raawwatiinsa ni qabaata.

ኢንዱዎ-መንገድ የተቋቋመበት ዓላማና ተልዕኮ ውጤታማ በሆነ መልኩ እንዲያሳካ እና የኢንዱዎ-መንገድ ተግባር በአሮሚያ ክልል የመንግስት ልማት ድርጅቶች ቁጥጥር ባለሥልጣን በኩል በቅርበት ክትትልና ቁጥጥር እንዲደረግበት ማድረግ አስፈላጊ በመሆኑ፤

ተሻሻሎ በወጣው የአሮሚያ ክልል ህገ መንግስት አዋጅ ቁጥር 46/1994 አንቀጽ 49 ንዑስ አንቀጽ 3(ሀ) መሠረት የሚከተለው ታውጏል፡፡

1. **አጭር ርዕስ**
ይህ አዋጅ “**የቴምሃ ኢንዱዎ-መንገድ ተጠሪነት አዋጅ ቁጥር 225/2012**” ተብሎ ሊጠቀስ ይችላል፡፡
2. **ትርጓሜ**
የቃሉ አገባብ ሌላ ትርጉም የሚያስጠው ካልሆነ በስተቀር በዚህ አዋጅ ውስጥ፡-
 - 1) “ባለሥልጣን” ማለት የአሮሚያ የመንግስት ልማት ድርጅቶች ቁጥጥር ባለሥልጣን ማለት ነው፤
 - 2) “ቦርድ” ማለት በኢንዱዎ-መንገድ ማቋቋሚያ ደንብ መሰረት የተመሰረተ የቴምሃ ኢንዱዎ-መንገድ ለአሮሚያ ልማት ሥራ አመራር ቦርድ ማለት ነው፤
 - 3) “ኢንዱዎ-መንገድ” ማለት በሲቪል ማኅበራዊ ድርጅቶች አዋጅ መሰረት የተመሰረተ ቴምሃ ኢንዱዎ-መንገድ ለአሮሚያ ልማት ማለት ነው፤
 - 4) “መንግስት” ማለት የአሮሚያ ክልል መንግስት ማለት ነው፡፡
3. **የተፈጻሚነት ወሰን**
ይህ አዋጅ የቴምሃ ኢንዱዎ-መንገድ በራሱ በሚያካሂዳቸው የማህበራዊና ኢኮኖሚያዊ የልማት ሥራዎች እና ኢንዱዎ-መንገድ ክልሎች ድርጅቶች ውስጥ ባለው ድርሻ ወይም ሼር ሁሉ ላይ ተፈጻሚነት ይኖረዋል፡፡

Whereas, it is necessary to ensure that the Endowment attain the objective and mission of its establishment effectively; and to make its activities to be closely followed and controlled by Oromia Regional State Public Enterprises Regulatory Authority;

Now, therefore, in accordance with Article 49 sub Article (3) (a) of the Oromia Region Revised Constitution, Proclamation No. 46/2001, it is hereby proclaimed as follows:

1. **Short Title**
This Proclamation may be cited as “**Tumsa Endowment Accountability Proclamation No. 225/2020.**”
2. **Definition**
Unless the context require otherwise, in this proclamation:
 - 1) “Authority” means Oromia Regional State Public Enterprises Regulatory Authority;
 - 2) “Board” means the management Board of Tumsa Endowment for the Development Of Oromia established in accordance with the Endowment’s establishment egulation;
 - 3) “Endowment” means Tumsa Endowment for the Development of Oromia established in accordance with Organizations of Civil Societies Proclamation.
 - 4) “Government” means Oromia Region Government.
3. **Scope of Application**
This proclamation shall be applicable to all social and economic development activities that Tumsa Endowment undertaken by itself and the shares that the Endowment holds in other organizations.

4. Ittiwaamama Indoowumantichaa
Caasaa fi gurmaa'insi Indoowumantichi qabu akkuma eegametti ta'ee, ittiwaamamni Indoowumantichaa Abbaa Taayitichaatiif ta'a.

5. Eegaa Ofaanaa Indoowumantichaa
Eegaa ol'aanaan Indowumantichaa Pirezidaantii Mootummaa Naannoo Oromiyaa ta'a.

6. Aangoo fi Hojii Abbaa Taayitaa
Aangoo fi hojiin seerota birootiin Abbaa Taayitichaaf kenname akkuma eegametti ta'ee, hojiirra oolmaa Labsii kanaatiif Abbaan Taayitichaa aangoo fi hojii armaan gadii ni qabaata:

- 1) Indoowumanticha ol'aantummaan ni hordofa; ni to'ata;
- 2) Karooraa yeroo gabaabaa, gid-dugaleessaa fi dheeraa Boordiin qophaa'ee dhiyaatuuf qoratee ni mirkaneessa;
- 3) Gabaasa raawwii hojii waliigalaa fi odiiitii boordiin dhiyaatu yeroo yeroon ni gamaaggama; kallattii ni kaa'a;
- 4) Amala hojii Indoowumantichaa giddugaleessa godhachuun ni hordofa; hojimaata ittiin hordofu ni diriirsa.

7. Deeggarsa Kennuu
Bulchiinsi Mootummaa, Manneen Hojii Mootummaa fi Abbaan Taayitichaa Indoowumantichi kaayyoo fi ergama hundeeffameef gahumsaan akka milkeessuuf deeggarsa faayinaansii, teeknikaa fi ogummaa ni taasisu.

8. Seerota Raawwatiinsa Hin Qabaanne
Labsiin, Dambiin, Qajeelfamnii fi barmaatileen hojii Labsii kanaan walfaallessan kamiyyuu dhimmoota Labsii kana keessatti hammataman irratti raawwatiinsa hin qabaatan.

4. የኢንዱዎ-መንቱ ተጠሪነት
ኢንዱዎ-መንቱ ያለው መዋቅር እና አደረጃጀት እንደተጠበቀ ሆኖ የኢንዱዎ-መንቱ ተጠሪነት ለባለሥልጣኑ ይሆናል።

5. የኢንዱዎ-መንቱ የበላይ ጠባቂ
የኢንዱዎ-መንቱ የበላይ ጠባቂ የኦሮሚያ ክልላዊ መንግስት ፕሬዝዳንት ይሆናል።

6. የባለሥልጣኑ ሥልጣንና ተግባር
በሌሎች ህጎች ለባለሥልጣኑ የተሰጠው ሥልጣንና ተግባር እንደተጠበቀ ሆኖ፣ ለዚህ አዋጅ አፈፃፀም ባለሥልጣኑ የሚከተሉትን ሥልጣንና ተግባራት ይኖረዋል፡-

- 1) ኢንዱዎ-መንቱን በበላይነት ይከታተላል፤ ይቆጣጠራል፤
- 2) በቦርዱ ተዘጋጅቶ የሚቀርብለትን የአጭር፣ የመካከለኛና የረጅም ጊዜ ዕቅድ መርምሮ ያጸድቃል፤
- 3) በቦርዱ የሚቀርበውን አጠቃላይ ሥራና የኦዲት ሥራ አፈፃፀም በየጊዜው ይገመግማል፤ አቅጣጫ ያስቀምጣል፤
- 4) የኢንዱዎ-መንቱን የስራ ባህሪ ማዕከል በማድረግ ይከታተላል፤ የሚከታተልበትን አሰራርም ይዘረጋል።

7. ድጋፍ ማድረግ
ኢንዱዎ-መንቱ የተቋቋመበትን ዓላማና ተልዕኮ በብቃት ኢንዲያሳካ የክልሉ መንግስት አስተዳደር፣ የመንግስት መስሪያ ቤቶች እና ባለሥልጣኑ የፋይናንስ፣ የቴክኒክና የሙያ ድጋፍ ያደርጋሉ።

8. ተፈጻሚነት የማይኖራቸው ህጎች
ከዚህ አዋጅ ጋር የሚቃረን ማንኛውም አዋጅ፣ ደንብ፣ መመሪያና ልማዳዊ አሰራር በዚህ አዋጅ ውስጥ በተሸፈኑ ጉዳዮች ላይ ተፈጻሚነት አይኖራቸውም።

4. Accountability of the Endowment
Without prejudice to its organizational set up and structure, the Endowment shall be accountable to the Authority.

5. Patron of the Endowment
The Patron of the Endowment shall be the President of Oromia Regional State.

6. Power and Duty of the Authority
Without prejudice to the power and duties given to the Authority by other laws, the Authority shall have the following power and duty for the implementation of this proclamation:

- 1) Follow up chiefly; control the Endowment;
- 2) Examine and approve the short, medium and long term plan prepared and submitted to it by the Board;
- 3) Evaluate the overall activities and audit performance reports submitted to it by the Board periodically; give direction;
- 4) Follow up the Endowment depending on its work nature; establish the system for its follow up.

7. Providing Support
The Government Administration, Government Institutions and the Authority shall provide financial, technical and professional support for the Endowment to attain the objective and mission for which it is established.

8. Inapplicable Laws
Any proclamation, regulation, directive and work practices inconsistent with this proclamation shall not be applicable on matters covered under this proclamation.

9. Yeroo Labsichi Hojiirra Itti Oolu
