- 29) Prepare and cause the implementation of the programs which help to support the elders and the disabled and to rehabilitate the disabled;
- 30) Mobilize, Organize and support the people to avoid social living problems;
- 31) Create conducive conditions to avoid unemployment and anti societal development and to make citizens productive;
- 32) Cause the implementation of workers and people's policy issued by Federal Government in the Region;
