1. **Mata Duree Gabaabaa**  
 Labsiin kun "Ummatni Miseensota Caffee Filate Irratti Ennaa Amantaa Dhabu Tarkaanfii Fudhatamu Ilaalchisee Labsii bahe lakkoofsa 22/1990" jedhamee waamamuu ni danda'a.

2. **Hiika**  
 Akkaataan jechichaa hiika biraa kan kennisiisuuf yoo ta'ee malee, labsii kana keessatti:

a) "Caffee" jechuun akka Heera Mootummaa Naannoo Oromiyaa keewwata 46(1), yookiin 74(1), yookiin 84(1) tti kan hundeeffame Caffee oromiyaa, yookiin Caffee Aanaa, yookiin yaa'ii Gandaa ti.

b) "Koree hojii raawwachiiftuu" jechuun akka Heera Mootummaa Naannoo Oromiyaa keewwata 53(1), yookiin 77(h) yookiin 85(3)tti kan hundeeffaman koree hojii raawwachiiftuu mootummaa Naannoo Oromiyaa, yookiin koree hojii raawwachiistuu bulchiinsa godinaa, yookiin koree hojii raawwachiiftuu Aanaa ykn yaa'ii gandaa ti.

1. Jiraataan Naannoo Oromiyaa kamiyyuu akkaataa seerri hayyamuun Caffee wwan sadarkaa adda addaatti bakka bu'aa isaa filachuuf mirga qaba.

2. Jiraataan Naannichaa kamiyyuu filattoota kanneen biroo wajjiin ta'uudhann haala bakka bu'aa isaa sakatta'uu, qorachuu fi madaaluu ni danda'a.

3. Jiraataan Naannichaa kamiyyuu deggarsa bakka bu'aa isaatiif kennaa ture dhiisuu, dhaabuu yookiin itti fufuuf mirga qaba.

1. **Short Title**  
 This Proclamation may be cited as the "Loss of Representation of Members of the Council Proclamation No. 22/1997."

2. **Definitions**  
 In this Proclamation, unless the context otherwise requires:

a) "Council" means the Oromia Council, wereda Council or Kebele Assembly established in accordance with the Constitution of the Oromia Regional State Article 46(1) or 74(1) or 84(1) respectively.

b) "Executive Committee" means the Executive Committee of the Regional State, Zone or Wereda or Kebele established in accordance with Articles 53(1), 77(h) and 85(3) of the Constitution of the Oromia Regional State respectively.

c) "Member" means a member of the council elected in accordance with Article 48(1) or 76 or 84(2) of the Constitution of the Oromia Regional State.

3. **Basic Rights**

1. Any resident of the Region has the right to elect members of councils established at all levels.

2. Any resident of the Region may, together with other electors, examine, evaluate, and weigh the member periodically.

3. Any resident of the Region has the right to withdraw or stop or maintain support for his member.

4. Amantaan Uummataa Akkaataa Itti Madaalamu

Miseensi Caffee tokko amantaa uummataa dhabeera kan jedhamu:

(a) Dambii Boordiin Filatnoo baasu irratti hundaa'uudhaan naannoo filatnoo miseensi Caffee Naannoo, bakka bu'aa bakka itti ta'etti filatoota argaman keessaa 15,000 ol kan ta'anu miseensummaa irraa akka ka'u gaaffii Boordii Flatnootiif yammuu dhiyeessan,

(b) Dambii Boordiin, Filatnoo baasu irraatti hundaa'uudhaan Naannoo Filatnoo, miseensi Caffee Naannoo bakka bu'aa bakka itti ta'etti yaadachiisa filatoota kuma kudhaniin dhiyaate deggaruudhaan Caffeen Aanaa sagalee caalmaan bakka bu'ichi debi'ee akka waamamu kan murteesse yoo ta'e;

(c) Dambii Boordiin Filatnoo baasu irratti hundaa'uudhaan Naannoo filatnoo miseensi Caffee Aanaa yookiin yaa'ii Gandaa bakka bu'aa bakka itti ta'etti filatoota argaman keessa 750 ol kan ta'anu miseensummaa irraa akka ka'u gaaffii Boordii Filatnootiif yemmuu dhiyeessan;

(d) Haala naamusa isaa irraa ka'uudhaan Caffeen inni miseensa itti ta'e sgalee 2/3n miseensichi uummata isa filate bakka bu'uuf ga'eesummaa hin qabu jedheen enna murteesse ta'a.

5. Madaallii Naamusummaa

Miseensi Caffee tokko naamusa isaatiin:

ለ) በተወከለበት የምርጫ ክልል በሚገኙ አሥር ሺህ መራጮች አሳሳቢነት የምርጫ ቦርድ በሚያወጣው ደንብ መሠረት የወረዳ ምክር ቤት በአብላጫ ድምፅ ተወካዩ ተመልሶ እንዲጠራ ውጤት ሲያሳልፍ፤

ሐ) የወረዳ ም/ቤት ወይም የቀበሌ ሽንጉ የሆነ አባል በተወከለበት የምርጫ ክልል ከሚገኙ መራጮች መካከል ከሰባት መቶ ሃምሳ በላይ የሆኑት የምርጫ ቦርድ በሚያወጣው ደንብ መሠረት የይወረድልን ጥያቄ ለምርጫ ቦርድ ሲያቀርቡ፤

መ) ተመራጩ አባል የሆነበት ም/ቤት ግለሰብ በሚያሳየው ሥነ-ምግባር የወከለውን ሕዝብ በብቃት ሊወክል አልቻለም ብሎ በሁለት ሦስተኛ ድምፅ ሲወስን ይሆናል።

፫. ስለ ሥነ-ምግባር መልካያዎች ማንኛውም የምክር ቤት አባል፡-

4. Any member has the right to convey clearly his opinion, oppose or accept the criticism, or offer commendation, thanks, gratitude and evaluation addressed to him by the electors.

4. Method of Evaluating the Confidence of the Electors

A member shall be deemed to have no confidence of the electors where:

a) in accordance with the Regulations to be issued by the Electoral Board, more than 15,000 electors of his constituency forward a demand to the Electoral Board that he step down;

b) upon initiation by 10,000 electors of his constituency and in accordance with the Regulations to be issued by the Electoral Board, the Wereda Council passes a decision by a majority vote to the effect that he shall be recalled;

c) upon initiation by 750 electors of his constituency and in accordance with the Regulations to be issued by the Electoral Board, a demand that a member of the Wereda council Kebele assembly be stepped down;

d) the council to which he is elected decides by a two-thirds vote that he has failed to competently represent his electors in view of the misconduct he has manifested.

5. Standards of good conduct  
Any member:

(a) Ittiin bulmaatni isaa akkaataa Heera Naann-ichaa keewwata 48(3) irratti ibsmeen sammuu isaatiifis waan ta'eef haala kamiiniyyuu qulqulluu ta'ee argamuu qaba;

(b) Dhimma uummataa irratti yammuu mari'atu, dhugaa-qabeessaa fi ifa ta'uuf itti gaafatama qaba;

(c) Ragaa sobaa uumuu; sobuu, dhimmoota hin qulqullaayin sobaan wal tajjii mariitti dhiyeessuun haallan muummeyyii namuusa dhabiinsi ittiin ibsamuu dha.

**6. Naamusummaa Dhabuudhaan Tarkaanfiiwwan Fudhataman**

1. Dhimmi miseensa namuusa dhabe jedhamee tokko koree Caffeen inni miseensa itti ta'e dhaabuun calalma.

2. Yaada murtee koreen dhim-micha calalee dhiyeessu irratti mari'achuudhaan Caffichi ni murteessa.

3. Caffichi, ennaa barbaachisaa ta'ee argame, miseensa hir'i-nni naamusa irratti mul'aterratti tarkaanfii kanatti aanu fudhachuu ni danda'a:

(a) Akkaataa uummataaf ifa ta'een akeekachiisni ofeeggatnoo kennamuu-fii ni danda'a;

(b) Yeroo murtaa'eef mise-ensummaa irraa ittisuun ni danda'ama;

(c) Keewwata kana (a) fi (b) irratti adabbiiwwan tumaman erga fudhatee booda naamusa dhabiinsi isaa yoo itti fufe Caffeen inni miseensa itti ta'e sagalee harka sadi keessaa lamaan (2/3) miseensummaa irraa haquu ni danda'a.

4. Keewwata kana (a-c) tti tarkaanfileen naamusaa ilaalamann akkuma ulfina badii miseensichaatiin, wal duraa duubni isaanii otoo hin eegamin fudhatamuu ni danda'u.

c) shall not create false evider ces, lie and forward unsubs tantiated matters to the floo which shall be taken as majo manifestations of miscon duct.

6. Measures to be taken agains misconduct

1. The case of a membe alleged for a misconduc behaviour shall be inves tigated by a committee established by the con cerned council.

2. The council shall de liberate upon the recom mendation of the com mittee of inquiry and pass its decision on the case.

3. The council may, when it deems necessary, take the following measures against the member who is found to be of miscon duct behaviour:

a) to issue him a war ning of reprimand which shall be made known to the public;

b) to suspend him from membership of the Council for a de finite time;

c) if the member con tinues with the mis conduct behaviour after the measures specified under (a) and (b) above are taken against him, the Council may cancel him from the membership by 2/ 3rd vote.

4. The disciplinary measures listed under sub-article 3(a-c) of this Article may be applied in disregard thereof, where the gravity of the fault so justifies.

4. Keewwata kana keewwata xiqqaa (3) jalatti yeroon ibsame baatii sadii hin dabru.

7. Consequences of Dismissal

1. When a member removed/recalled in accordance with Articles 4 and 5 of this Proclamation his Identity Card shall become invalid.
2. Without prejudice to the provisions of sub-article (1) of this Article, the former member whose representation is cancelled may not participate in the election that shall be conducted to replace him.
3. The election time governed by sub-article (2) of this Article shall take place within the time when the Executive Committee of the Regional State decided in consultation with the Electoral Board.
4. The time governed by sub-article (3) of this article shall not exceed beyond three months.

8. Repeal

From the provisions of Proclamation No. 5 (Definition of Rights and Duties of Council Members), the following articles are hereby repealed:

- a) Article 9,
- b) Article 11 (a) and (b),
- c) Article 12 sub-article(1),
- d) Article 13.

9. Effective Date

This Proclamation shall become effective beginning November 9, 1997.
